02. Bidding Procedure: Bidding will be conducted through the **National Competitive Bidding (NCB)** procedure.

03. Eligibility Criteria: To be eligible for the award of the contract, the successful bidder must not have been blacklisted and shall hold a valid registration under the **Business Names Act** or **Companies Act** for the supply, manufacture, or import of goods and equipment.

04. Inspection of Documents: Interested bidders may obtain further information from the Procurement Branch and may inspect the Bidding Documents free of charge at the address given below between **09:00 hrs and 15:00 hrs** on working days, from **23.04.2026 to 13.05.2026**.

05. Purchase of Bidding Documents: A complete set of Bidding Documents in English Language may be purchased by interested bidders upon submission of a written application to the **Director General, Department of Sports Development, No. 09, Philip Gunawardana Mawatha, Colombo 07**, from **23.04.2026 to 13.05.2026** between **09:00 hrs and 15:00 hrs** on working days, upon payment of a non-refundable document fee of **Rs. 12,500.00** **The method of payment will be in cash only.**

06. Bid Security: All bids must be accompanied by a Bid Security for the value specified in the table above. The security must be an unconditional guarantee issued by a commercial bank approved by the **Central Bank of Sri Lanka**, in favor of the **Director General, Department of Sports Development**. Bidders applying for multiple sports categories may submit a single consolidated Bid Security covering the total required value (please attach a note specifying the security value for each category). The Bid Security shall be valid until **10.09.2026** (119 days from the date of bid closing).

07. Pre-Bid Meeting: A pre-bid meeting will be held on **30.04.2026 at 10:00 a.m.** in the Ministry Mini Auditorium.

08. Performance Security: The successful bidder shall furnish a Performance Bond equivalent to **10% of the total contract value.**

09. Bid Validity: Bids shall be valid until **13.08.2026** (91 days from the date of bid closing).

10. Submission and Opening of Bids: Sealed bids in duplicate, clearly marked "**Original**" and "**Duplicate,**" must be delivered to the address below or deposited in the Tender Box located at the **Procurement Division, 2nd Floor, Department of Sports Development, No. 09, Philip Gunawardana Mawatha, Colombo 07**, on or before **14:00 hrs (2:00 p.m.) on 14.05.2026**. Bids will be opened immediately thereafter in the presence of the bidders or their authorized representatives. **Late bids will be rejected.**

11. Sample Inspection and Quality Assurance: Bidders shall submit samples for each item in accordance with the specifications As charge below
